Sealed quotations are invited from reputed Contractor/repairer/authorized dealer for filling up Fire Extinguishers installed in vessels deployed at Pandu port Guwahati, as per annexure & as per terms and conditions laid down below. (2) The repair work may be done as per following terms and conditions mentioned below:

- (i) The price may be quoted in both words and figures.
  - (ii) The price may be quoted including all the cost such as labour, transportation charges, all taxes excluding Good & Service Tax (GST) as applicable which will be paid on production of proof of payment. **No other charges shall be entertained.**
  - (iii) The refilling work must be completed within 15 days from the date of receipt of order at IWAI, Guwahati office at Pandu Port and must submit a refilling certificate.
  - (iv) The firm has to submit documentary evidence of current copy of the Registration Certificate of the firm, PAN, GSTN certificate.
  - (v) Refilling should be done from Authorized dealer / Distributor / reputed firm and GST bill must be submitted. Copy of E-way bill shall be submitted whenever necessary.
  - (vi) The payment shall be made by RTGS within 15 days from the date of receipt of bill and challan after satisfactorily work done. The copy of RTGS details shall be submitted along with quotation.
  - (vii) In Case of delay in completion of work liquidity damage @0.5% per week subject to a maximum of 5% will be deducted.
  - (viii) IWAI reserves the right to accept or cancel any / all quotations without assigning any reason or any prior notice.
- (3) The sealed quotation should reach this office latest by **10.8.2022 at 15:00 hrs** and will open on same day at **15.30 hrs**. No quotation will be accepted after the last date and time for submission of quotations.
