NOTICE INVITING QUOTATION

Quotations in sealed envelope are hereby invited by the undersigned on behalf of Director, IWAI, Kolkata from reputed contractors/agencies for supply of a mechanised country boat at Jangipur lock as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – I with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to undersigned.

Sealed quotations will be received upto **3:00PM on 01.10.2022 at the office of the Assistant Director, I.W.A.I., Office Building No. 1, FBP Office Complex, PO- Farakka Barrage, PS- Farakka, Murshidabad and will be opened on same day at 4:00PM.** in presence of the contractors/agencies or their authorised representatives.

Rates should be quoted inclusive of all charges but excluding GST. The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all expenses like hire charges, POL, maintenance, incidental charges etc. No extra charges will be payable except GST.
- 2.0 The above supply work should be as per the BOQ & directives of Engineer In Charge or his authorised representative. In case of the supplied boat found in improper condition the supplier should replace the same within one at his own mobilization/de-mobilization cost.
- 3.0 The boat should be mobilized to site within 3 (three) days from the date of the supply order.
- 4.0 The deck of the boat should be well covered with thick plastic sheets and same to be changed if found damaged during the site activities.
- 5.0 Full payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative within 30 (Thirty) days after satisfactory completion of the work. However, Authority will not be responsible for any unavoidable delay.
- 6.0 The firm will be required to submit original Tax-Invoice in duplicate at the time of submission of the claim.

- 7.0 In case of malfunction of the boat, same to be replaced/repared by the agency at his own cost within two days of the fault detected at site. No payment will be considered in case of boat could not be operated during any working-day or part thereof.
- 8.0 The quotation should accompany GST registration, valid Trade License and experience on any similar work carried out at any Government/Quasi-Government/P.S.U. within last 7 years.
- 9.0 Incomplete quotations will be summarily rejected.
- 10.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
