The estimated cost for the mentioned works will be Rs. 1,14,400/- excluding GST (to be quoted) and cost of spares for an amount of Rs.48,800/- excl GST (not to be quoted in the price schedule) will be extra on actual +10% including transportation charges. The materials should be genuine and as per specifications mentioned in B.O.Q is enclosed as Annex-1
- 2. The repair works must be completed within 20 days from the date of issue of this work order.
- The payment shall be made through PFMS within 15 days after submission of bill and certification of the work by the concerned office I/C.
- 4. The firm should submit self certified copy of PAN card, registration certificate of firm, GST registration number, last year ITR along with the quotation, Bank details & Cancelled cheque where payment to be made, similar work done experience certificate.
