- 1.0 Documentary proof of undertaking repairing of DG sets in last 03 years to be submitted by the bidder.
- 2.0 The rates should be quoted inclusive of all taxes, labour, transportation etc. no extra cost will be admissible.
- 3.0 The above work shall be carried out at the address mentioned in Para-1 as per specification mentioned in the B.O.Q. (Annexure A) and direction of E.I.C. or his representative.
- 4.0 The above work shall be completed within 10 (Ten) days from the date of issue of the work order, which includes to & fro journey to Hemnagar.
- 5.0 90% payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative.
