Inland waterways authority of India (IWAI) invites quotations from experienced and reputed firm/company for erection/fabrication work and others miscellaneous work at Ayodhya in NW-40 as per enclosed BOQ.

### **The terms and conditions are as under:-**

- 1.) The price may be quoted including all the costs such as labourer, materials and transportation etc. as per annexure-I. No other extra charges will be entertained except GST which shall be reimbursed as per applicable.
- 2.) The work shall be completed at Ayodhya, within 10 (Ten) days from the date of handed over the pontoon.
- 3.) The firm should also require submit self-certified copy of PAN Card, GST registration certificate and credential certificate of similar nature of work.
- 4.) 90% of payment will be made by RTGS within fifteen days from date of receipt of the bill and duly certification of the bill by the officer concerned after deducting the statutory dues if any. Rest 10% of amount will be released after expiry of guarantee period and duly certificate by officer concern.
- 5.) The work shall be under guaranteed period of six months from the date of completion of work.
- 6.) In case of delay in completion of work, liquidated damage 1% per week subject to a maximum of 10% will be charged.
