NOTICE INVITING QUOTATION

Sealed quotations are hereby invited from the contractors / agencies for supply of one mechanized country boat (25 BHP) in Bansjhari, Mallickpur (Chainage 0 km) to Kalanchi (63.38 km) of National Waterway No: 44 for undertaking fortnightly Thalweg survey / channel assessment survey / inspection and other allied works as per site requirement. The boat shall also be used for removal of water hyacinth from navigational channel and clearing obstruction while undertaking thalweg survey. The terms & conditions are detailed below. The details of the work and B.O.Q are enclosed as Annexure — A with this N.I.Q which is to be filled in and submitted along with a forwarding letter addressed to **Director**, **IWAI**, **P-78**, **Garden Reach Road Kolkata-700 043**.

Sealed quotation will be received up to 3:00 PM on 07/09/2024 and will be opened on same day at 4:00 PM. The contractors / agencies or their authorized representatives (with authorization letter) who have submitted the quotations may also be present during opening of same by the committee members of R O Kolkata.

Rates should be quoted inclusive of all charges but excluding GST. The rates shall be quoted legibly both in figures and words and shall be valid up to 31st March 2025 from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- The rates should be quoted inclusive of all expenses like hire charge, POL (for approximately operation of 07 to 08 hours per day), maintenance, boatmen, incidental Charges etc. No extra charges are payable except GST only on submission of valid receipts.
- 2. The above supply works shall be carried out as per requisitions contained in B.O.Q. (Annex A) enclosed and as per directives of Director, IWAI, Kolkata or his representative of Engineer-In-Charge.
- 3. The mechanized country boat shall be initially hired for approximately 12 to 14 days or more as per site requirement in each month during the period September'2024 to March'2025 for undertaking fortnightly Thalweg survey / channel assessment survey / inspection of dredging activities and other allied works etc. The boat shall also be used for

removal of water hyacinth from navigational channel and clearing obstruction while undertaking thalweg survey. 02 day for mobilization and 02 day for de-mobilization shall be considered per month. The deployment period may be also reduced due to change of scope of work, if any.

- 4. The mechanized country boat should be mobilized at Basirhat / Itinda Ghat or Kalanchi / Taranipur on NW-44 on the day of commencement of fortnightly survey / inspection by the successful bidder for which the written intimation shall be conveyed by the Enginner-in-charge or his representative 02 days in advance.
- 5. In case of any malfunction of the mechanized country boat, same is to be replaced / repaired by the agency at their own cost within stipulated time so that hydrographic survey / inspection activities are not hampered. In case of major breakdown in the mechanized country boat supplied by the firm, replacement mechanized country boat is to be provided within 12 hours or as directed by engineer-in-charge/his representative within stipulated period. No payment shall be considered in the case mechanized country boat is non-operational for the day or part thereof.
- 6. The mechanized country boat should be well covered with thick plastic sheets and should be changed immediately if found damaged during the site activities.
- 7. In case of delay in supply of boat liquidated damage @ 0.5% per day shall be applicable per day subject to maximum of 5% will be charged of the awarded value which will be deducted from the monthly bill.
- 8. Claims for damages or loss of boat and life due to accident / payment of third party involved or otherwise either natural calamity or other reasons whatsoever shall not be entertained by IWAI and shall be the sole responsibility of the mechanized country boat supplier.
- 9. The firm will be required to submit original Tax-Invoice in duplicate at the time of submission of the claim. Payment will be released on monthly basis after successful completion of the work after necessary certification by Engineer-In-Charge or his authorized representative.
- 10. GST registration, valid Trade license and experience of similar work carried out at any Government/Quasi-Government/ P.S.U within last 05 years.
- 11. Incomplete quotations will be summarily rejected by Competent Authority.
