- 5 Any condition, in any form will not be accepted and placing of condition will be considered for the rejection of the quotation.
6. The material shall be loaded at Gaighat, Patna and all necessary arrangement for loading & unloading will be done by the transporter at Patna and MMT Haldia, West Bangal respectively at their own cost on arrival at MMT Haldia, handover the all material to Director (i/c) IWAI Kolkata.
7. Interested transporter may inspect the material on any working day on 11.03.2024 to 12.03.2024 from 1100 hrs to 1700 hrs at Gaighat, Patna.
8. All the quotations shall be addressed to the Director, IWAI, Gaighat, Patna 800007 in a sealed cover. Quotation will be received upto at 15:00 hrs on 13.03.2024 and will be opened on the same day at 15:30 hrs by the officers of the IWAI in the presence of the representative of tenderers who choose to attend.
