## **NOTICE INVITING QUOTATION**

Sealed quotations are invited from experienced contractors/agencies for providing boat, tractor & vehicle to carry out departmental Talway surveys in Indian portions of Indo-Bangladesh Protocol (IBP) Route no. 5 & 6 under Protocol on Inland Water Transit & Trade (hereinafter referred as PIWT&T) during September 2024 to March'2025. as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – A with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to the Director, IWAI, Kolkata.

Sealed quotations will be received upto **3:00 P.M. on 06.09.2024** at the **office of the Assistant Director, Office Building No:1, FBP Office Complex, P.O: Farakka Barrage, West Bengal -742212** and will be opened on same day at **4:00 PM.** in presence of the contractors/agencies or their authorised representatives. In case authorised representatives, they are required to bring authorisation letter.

Rates are be quoted inclusive of all charges but excluding GST. The rates shall be quoted legibly both in figures and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

### **Terms and Conditions:**

- 1.0 The rates should be quoted inclusive of all expenses like labours, operators', Manjhi, driver, incidental, mobilization charges etc. No extra charges will be payable except GST & toll charges subject to submission of original receipt.
- 2.0 The above supply works shall be carried out as per requisitions contained in B.O.Q. (Annexure – A) enclosed.
- 3.0 The requisite boat, tractor & vehicle to be arranged for carrying out Hydrographic survey works in the Indian portions of PIWT &T route 5 & 6 at following locations:

- 4.0 The above supply work to be carried out as per directives of Officer in Charge, Farakka who will be the representative of Engineer in Charge. The requisitions for Boat/Tractor will be raised by Farakka Sub Office on previous day and will be communicated by email & telephone to the successful bidder.
- 5.0 The deployment will be on need basis only and may vary as per the actual site requirements/conditions. No compensation in account of deployment days will be considered under any circumstances.
- 6.0 Payment in form of running account bills at an interval not less than 3 (three) months will be made only after satisfactory completion of the work during the claimed period and necessary certification by Engineer-In-Charge. or his Authorised representative within 30 (Thirty) days. However, Authority will not be responsible for any unavoidable delay.
- 7.0 The quotation must accompany self-attested copies of valid Trade License, GST Registration Certificate (Form-06).
- 8.0 The participating agencies must have experience in similar supply works or in river conservancy/training works carried out in any Government/Quasi-Government/P.S.U./State irrigation and waterways department etc. within last 7 years. The agency should enclose relevant credentials with the quotation.

- 9.0 Incomplete quotations will be summarily rejected.
- 10.0 On delay in supply of Boat, Tractor & Vehicle a Liquidated Damage @ 0.5% of the work value on each occasion will be deducted from the final bill.
- 11.0 The work may be extended for another three months in case of exigency and satisfactory performance of agency. However, it will be sole authority of IWAI to grant such extension or not.
