NOTICE INVITING QUOTATION (NIQ)

Introduction

The Inland Waterways Authority of India invites sealed quotations from reputed experienced firms in a single cover for: "Shifting of office furniture & fixtures from existing premises at BSNL Residential Quarters at Sanjay Nagar Colony to MMT Ramnagar, Varanasi-reg.."

1. Scope of Work

The scope under this contract shall broadly include:

- (a) All works related to Shifting of office furniture & fixtures from existing premises at BSNL Residential Quarters at Sanjay Nagar Colony to MMT Ramnagar, Varanasi. but not limited to: -
 - (i). Mobilization & Demobilization of transportation of vehicle & necessary equipment's as per requirement at BSNL Residential Quarters at Sanjay Nagar Colony to MMT Ramnagar, Varanasi.
 - (ii). Dismantling of furniture & fixtures (including labelling & packing of equipment for safe transportation) as required.
 - (iii). Loading of furniture & fixtures and all officials documents with detailed packing list as required for safe transportation.
 - (iv). Transportation of office goods and equipment's along with all accessories from BSNL Residential Quarters at Sanjay Nagar Colony to MMT Ramnagar, Varanasi.
 - (v). Unloading of office goods and equipment's 0.5 km (including crane & handling charges) as required.

- (b) Manpower & Equipment: Deployment of all required personnel, equipment, vehicles, cranes, trailers, and other logistics infrastructure.
- (c) Compliance: Ensuring all permissions, documentation, road permits, and statutory approvals are obtained and maintained throughout.

- i. The entire items such as documents, furniture and electrical fittings etc. shall be shifted carefully and no damages/loses shall be occurred while handling /loading/unloading or transportation of the same one location to another.
- ii. The bidder will be fully responsible for any damage during the scope of work and such costs will be recovered by IWAI if required.

3. Timeline

The entire work shall be completed within 05 (five) days from the date of award of the contract (LoA).

- 4. Documents to be Submitted with the Quotation Bidders are required to submit the following along with their quotation:
 - (a) Copy of PAN Card.
 - (b) Copy of GST Registration Certificate.
 - (c) Authorization Letter (if applicable) for signing and negotiation.

- (d) Original NIQ document, duly signed & stamped by the authorized signatory on every page.
- (e) Experience of executing similar works within last 7 years.
- (f) Duly filled Schedule of Price (Form Fin-1).

5. Pricing & Taxation

- (a) The price may be quoted including cost of packing of office documents, furniture, electrical/sanitary fittings (as at Annexure-2) and shifting/transporting the same from the existing office space located at Ground and 1st floor of Sanjay Nagar Colony, Chukaghat, Varanasi to our new premises at MMT Ramnagar, Varanasi (Ground & 1st Floor) as per the specifications on BoQ (Annexure-1). No other extra charges will be entertained in any manner.
- (b) The price quoted shall be firm and inclusive of all costs including duties, taxes, royalties, levies, packing, transportation charges, labor, equipment and incidentals excluding GST.
- (c) GST shall be paid as per applicable rates at the time of payment, in line with Government guidelines on submission of proof of its remittance.
- (d) No escalation/adjustment of rates shall be permitted for any reason during the execution period.

6. Currency & Payment

- (a) All quotations shall be submitted in Indian Rupees (INR) only.
- (b) On completion of all works, necessary bill must be submitted to IWAI, Varanasi Regional office.
- (c) Payment shall be released after due certification of bill by concerned official within 30 days after deduction of statutory dues, as applicable.
- (d) All payments shall be made in Indian Rupees (INR) only and shall be subject to applicable Indian Laws for the purpose of taxation, if any.

(a) A Security Deposit (SD) equivalent to 10% of the awarded contract value will be deducted from bill.

(b) The SD shall be released upon successful completion of the contract and settlement of final payment, ensuring no outstanding claims after due certification by concerned officials.

8. Completion Period & Liquidated Damages (LD)

- (a) The work must be completed within 05 (five) days from the date of award.
- (b) In case of delay (without justifiable cause), LD @ 0.5% of the total value of work for per day of delay will be levied, subject to a maximum of 10% of the awarded cost.
