- 5. Payment will be made through E-mode within 30 days after receipt and certification of the bill by concerned officer after deduction of the statutory dues, if any.
- 6. The work must be completed well before the stipulated time i.e., preparation as well as audit of annual accounts and return to be filed with concerned Authority. The concerned CA Firm will bear the charges in the form of penalty, interest etc. for unnecessary delay and error made during as well as after completion of service.
