- The tendering firms must have at least three years of experience in carrying out Hydrographic / Bathymetric surveys in rivers using Automated Hydrographic Survey System (AHSS), post processing, preparation of drawings and submission of reports as stipulated independently.
  - The tenderer should be conversant with the similar work and should submit credential for similar works carried out by them.
  - Tenderer shall have to submit the Permanent Account Number.
  - Average annual financial turnover during last 3 years ending

- v. Experience of having successfully completed similar works during the last 3 years ending last day of month previous to the one in which this tender is invited should be either of following:
    - a) Three similar works completed not less than 40% of the estimated cost; **or**
    - b) Two similar works completed not less than 50% of the estimated cost; **or**
    - c) One similar work completed not less than 80% of the estimated cost
  - vi. Latest certificate (not less than 4 months) of **Solvency** from nationalized / scheduled Bank included in the second schedule of the RBI Act for not less than **Rs.68,35,853/-** shall be submitted along with the bid.
  - vii. The Firm must have an IV registered Vessel committed for the duration of 3 years.
  - viii. The Firm must have a local office for the duration of the contract.
