Sub: Notice Inviting Quotation for hiring of OBM operator and labour on need basis for Hydrographic Survey & other survey related activities in Kahalgaon Munger stretch (NW-1) for period of August 2024 to March 2025-reg.

Inland Waterways Authority of India (IWAI) invites Sealed Quotations for hiring of OBM operator and labour on need basis for Hydrographic Survey & other survey related activities in Kahalgaon Munger stretch (NW-1) as per Description of work (Bill of Quantity) for the for period of August 2024 to March 2025. Description of work is enclosed as Annex-A.

The terms and conditions are as under: -

1. The contractor must be paid to OBM operator and labour @ Rs. 862/- and Rs. 651/- per day respectively.
2. The rate should be inclusive of all taxes (GST) as applicable and terms of price should be in Indian Rupees (INR). No other claims will be entertained. The GST amount shall be released on submission of its remittance. Only service charge will be quoted by the contractor.
3. The Service provider shall submit PAN Number, GST Registration, Cancel cheque (Copy) and firm must enclose proof of similar work done for PSU/ Statutory body or any Government agency.
4. Payments shall be released on submission of bill within 15 days after deduction of statutory dues if any and duly certification by concern officials/officers.
5. The quotation must have validity of at least three months.
6. If the work has not completed within the stipulated time LD of ½ % per week is to be charged, subject to maximum 10% of the work order value.
7. Price bid shall be submitted in the format attached at Annexure-I which should be duly signed and stamped by the service provider and without any deviation/condition.
8. Inland Waterways Authority of India (IWAI) reserves the right to accept or cancel any quotations without assigning any reason or any prior notices.
9. The sealed quotations shall be submitted up to 13.08.2024 before 15:00 hrs at IWAI, Patna along with copy of GST registration certificate, PAN card, Bank Account detail/Cancelled Cheque. Quotation received late shall not be entertained.
10. On receiving of the work order, firm will have to submit Security deposit of 10 % value of awarded work in favour of IWAI FUND, A/c no. - 0352105000002, IFSC code- CNRB000352 and attend the office at Patna along with two non Judicial stamp paper of Rs. 1000/- (Rs. one thousand only) each to enter into Formal agreement and Integrity agreement within 15 days from the date of issue of work order.
11. The supply order may be extended after expiry of work order subject to mutual agreed by firm on same rate terms & conditions. The received quotations will be opened at IWAI Patna on dtd 13.08.2024 at 15:30:00 hrs.
