NOTICE INVITING QUOTATION

Sealed quotations are invited from the reputed firm / suppliers for supply of 01(one) No. Power driven boat with engine with 1 (one) Nos. crew (for eight hours/day) and unskilled manpower for utilization by authority in various dredging works at Farakka in D/s Nav. Lock Channel/Feeder Canal for a period of three months.

Terms & Conditions: -

- 1. The boat is to be deployed at D/S RCC Jetty, Farakka in D/s Lock channel while IWAI reserves the right to utilize the boat in any other urgent departmental work.
- **2.** The rates are to be quoted both in words and in figures. The rates shall be inclusive of all charges and delivery at site.
- **3.** Supply of boat with Manjhee on hire charges basis shall be made available immediately on issue of the order.
- **4.** The boat shall be well equipped with all accessories and appliances as per existing rules and all safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost.
- **5.** Maintenance and repair of the boat shall have to be done by the supplier at his own initiative and cost to the satisfaction of the department. As such, price must be quoted inclusive of repair and maintenance cost also, if any.
- **6.** The actual site of operation of boat services will be monitored by the Engineer-in-Charge or his authorized representative.
- 7. Boat with Manjhee will be deployed on 'No work no pay' basis. Therefore, the Department will not entertain any claim of idle period due to breakdown, if any. Basis of calculation of quantity of the executed work in such case:-

The boat shall be supplied on monthly hire basis and unskilled manpower shall be supplied on man month basis as per requirement. However, in case of partial utilization of boat in any month due to reasons attributable to the contractor, payment shall be done on pro-rata basis considering 26 working days in a month. For example, for 15 days deployment of boat/manpower in a month 15/26 * monthly hire charges against the partial deployment shall only be will be paid.

- **4.** Necessary compensation in case of any accident will have to be paid by the supplier as per rule and it solely responsibility of the agency to take all necessary/applicable insurance policy etc. IWAI will not be held responsible for any such unforeseen events and no compensation shall be paid by IWAI.
- **5.** E-Payment will be made after submission of pre-receipted bills in triplicate by the supplier. No advance payment is admissible.
- **6.** The undersigned reserves the right to reject any part or whole of the quotation without assigning any reason whatsoever.
- **7.** Authority reserves the right to extend the pact as shall be required up to 1 month (maximum one time), subject to requirement, satisfactorily performance and willingness of the contractor.
- **8.** The supplier shall take care of all statuary compliance applicable to the work as per applicable acts/rules/regulations.
- **9.** Payment will be made by cheque/RTGS within 15 days from the date of completion of the work and certification of the monthly running bill by the officer concerned after deduction of the statutory dues.
