NOTICE INVITING QUOTATION (NIQ)

Sealed quotations are hereby invited from reputed contractors/agencies for supply of Unskilled workmen on need basis for the work of pipeline dredging purpose and day to day logistic support during dredging to Amphibian Dredger Falgu (A.D Falgu) from Tentulia (Chainage 40 Km) to Kalanchi (Chainage 63.38 Km) stretch on National Waterway No:44 from December'2024 to June'2025 as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure -I with N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to **Director**, **I.W.A.I.**, **P-78**, **Garden Reach Road**, **Kolkata-700043**

Sealed quotations will be received up to 3:00 PM on 13/12/2024 and will be opened on same day at 4:00 PM. The contractors/agencies or their authorized representatives who have submitted the quotations may also be present during opening of same by the committee members of IWAI.

The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The work for which quotation has been submitted should be clearly written on the top cover of sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all expenses including safety items no extra charges will be payable, except G.S.T as applicable.
- 2.0 The above supply work should be as per the BOQ in ANNEX A & directives of Engineer in Charge or his authorized representative.
- 3.0 The period of work will be for 6 months w.e.f from December'2024 to June'2025 on need basis. However, the actual deployment may vary as per site requirement and may be extended.
- 4.0 Manpower engage by the agency should follow the rate of CLC. Payment is to be released as per Minimum wages Act, 1948 and Central Rules, 1950 as per classification of cities and all the statutory deposit are to be made to the respective concerned department / Bodies.

- 5.0 The workmen should know swimming and capable to work in river.
- 6.0 The location to arrangement of pipeline as indicated in the BOQ may be different base on actual requirement of IWAI.
- 7.0 Claims for injury or loss of life due to accident for the work of pipeline during dredging activities / payment of third party involved or otherwise either natural calamity or other reasons whatsoever shall not be entertained by IWAI and shall be the sole responsibility of the supplier.
- 8.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
- 9.0 At the time of submission of bill the copy the following documents are to be furnished:
 - a) Duly certified Muster Roll for the billing month.
 - b) Mode of payment should be digital mode and receipt to be submitted for the billing month.
- 10.0 The firm should deposit the copies of the following:
 - a) GST Registration
 - b) Copy of PAN
 - c) Cancelled Cheque
 - d) Trade License
 - e) Registration with EPFO & ESI
 - f) Experienced certificate (Minimum up to estimated cost)
- 11.0 Successful bidder is requiring to submit two non-judicial stamp paper of Rs. 100/- each to enter into formal Agreement and Integrity Agreement.
- 12.0 Incomplete quotations will be summarily rejected.
