Any incremental spare costs must be prior approved by the Competent Authority. No additional charges will be entertained. GST will be extra as applicable.
  - The repair work must be completed within 10 days from the date of (iii) receipt of order from R.O. Kolkata.
  - (iv) The firm has to submit documentary evidence of current copy of the Registration Certificate, PAN, GST and Experience with similar work.
