NOTICE INVITING QUOTATION

Sealed quotations are invited from experienced contractors/agencies for Supply of an inflatable boat for carrying out Hydrographic surveys in rivers as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – A with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to R.O. Kolkata.

Sealed quotations will be received up to 3:00PM on 23.08.2021 at the office of the Director, I.W.A.I., P-78, Garden Reach Road, Kolkata – 700043 and will be opened on same day at 4:00PM. in presence of the contractors/agencies or their authorised representatives. In case authorised representatives, they are required to bring authorisation letter.

Rates should be quoted inclusive of all charges but excluding GST. The rates shall be quoted legibly both in figures and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all expenses like materials, accessories and transportation up to Farakka etc. No extra charges are payable except GST only on submission of receipt.
- 2.0 The above supply works shall be carried out as per requisitions contained in B.O.Q. (Annexure – A) enclosed within one week from the date of the work order.
- 3.0 The requisite inflatable boat should have length 4-5 m. & width 1.8-2 m. and made of high-density polyamide materials.
- 4.0 The boat should capable to carry payload equivalent to weight of 8 persons and having buoyancy tube not less than 500 mm.
- 5.0 The boat should accompanied with the following accessories:
 - a) Aluminium oars with oar locks 2 nos.
 - b) Inflator (electrically drivable) 1 no.
 - c) Inflator (foot drivable) 1 no.
 - d) Repair kit 1 set.
 - e) Transducer mounting arrangement 1 no.
 - f) Carrying bag 1 no.
- 6.0 All materials including accessories should come with at least one year warranty.

- 7.0 The above supply work to be carried out as per directives of Officer In Charge, Farakka who will be the representative of Engineer In Charge.
- 8.0 80% of the awarded value will be paid after 15 days of successful delivery and commissioning of the boat at Farakka. The remaining 20% will be released after expiry of the warranty period.
- 9.0 The quotation should accompany self attested copies of valid Trade License, GST Registration Certificate (Form-06) and work experience credential pertaining to supply of inflatable/FRP boat etc. carried out in any Government/Quasi-Government/P.S.U. during last 7 years.
- 10.0 The quotation should contain G.S.T. number of the agency.
- 11.0 Incomplete quotations will be summarily rejected.
- 12.0 On delay in supply of the material Liquidated Damage @ 1% per week and maximum of 10% of the awarded value will be deducted from the supply bill.
