- Payment will be made through e-payment after completion of work and duly certification of the bill by concerned officer after deduction of the statutory dues, if any.
- 4. The firm has to submit self certified copy of PAN Card, GST registration, cancelled cheque & certificate related to similar / relevant work experience.
- 5. The work shall be completed within 10 days from the receipt of the work order, failing which 0.5% per week L.D will be imposed.
- 6. Security Deposit/Retention money shall be 5% of the value of executed works and will be deducted from the bill of subject work. Retention money will be released on request of Contractor / Agencies after Defects Liability period is over.
