Inland Waterways Authority of India (IWAI) invites Sealed Quotations for hiring of O.B.M. engine-based country boatincluding crew members and 1 no. contigentlabourfor conducting hydrographic survey activities in Chunar - Prayagraj stretch of NW-01 (River Ganga) during the month of November 2024 to December 2024 (02 Months). Description of work is enclosed as Annex-A.

The terms and conditions are as under: -

- The rate should be inclusive of all taxes (GST) as applicable and terms of price should be in Indian Rupees (INR). No other claims will be entertained. The GST amount shall be released on submission of its remittance.
- 2. The Service provider shall submit PAN Number, GST Registration, cancel cheque (Copy) and firm must enclose similar work done certificate/work order issued by PSU/Statutory body or any Government agency.
- 3. Payments shall be released on submission of bill within 15 days after deduction of statutory dues if any and duly certification by concern officials/officers and running charges will be paid on submission of HSD purchase bill & certified Log book.
- 4. The quotation must have validity of at least three months. The boat must be made be available as per requirement within 7 days on submission of of indent for supply of boat.
- 5. If the work has not completed within the stipulated time LD of ½ % per week is to be charged, subject to maximum 10% of the value.
- 6. Price bid shall be submitted in the format attached at Annexure-A which should be duly signed and stamped by the service provider and without any deviation/condition.
- 7. Inland Waterways Authority of India (IWAI) reserves the right to accept or cancel any quotations without assigning any reason or any prior notices.
- 8. The sealed quotations shall be submitted up to 28.10.2024 before 15:00 hrs at IWAI, Patnaalong with copy of GST registration certificate, PAN card, Bank Account detail/Cancelled Cheque. Late received will not be entertained.

On receiveing of the work order, firm would have to submit Security deposit of 10 % value of awarded work in favour of IWAI FUND, A/c no. - 0352105000002, IFSC code- CNRB000352 and attend the office at Patna along with two non-Judicial stamp paper of Rs. 100/- (Rs. one hundred only) each to enter into Formal agreement and Integrity agreement within 15 days from the date of issue of work order.
