#### Terms & Conditions:

1. The estimated cost for the mentioned works will be Rs. 1,72,200/- (excluding GST) including transportation charges. The materials should be genuine and as per specifications mentioned in B.O.Q is enclosed as Annexure.
2. The repair work shall be completed within 30 days from the date of issue of this supply order.
3. The payment shall be made through PFMS within 15 days after submission of bill and certification of the work by the concerned office I/C.
4. The firm should submit self-certified copy of PAN card, registration certificate of firm, GST registration number, last year ITR along with the quotation, Bank details & Cancelled cheque where payment to be made, proof of similar work done for qualify technically for this work.
5. Firm has to submit EMD of Rs.5,000/- through RTGS/NEFT only payable in favor of "Inland Waterways Authority of India" in the A/c no. 39360627884, State Bank of India, Vyttila Branch IFSC:SBIN0008694. The scanned copy of the RTGS/NEFT receipt with transaction ID must be enclosed along with the bid.
6. The bidder shall inspect the sample of items office prior to quote the rates and submission of quotation for the above said work.
7. The quoted price shall be excluding GST as per applicable.

8. In case of delay in completion of the above delivery, liquidated damages will be applicable @ 1.0% per week subjected to a maximum 10% on the total value of contract.
