#### **NOTICE INVITING QUOTATION**

Quotations in sealed envelope are hereby invited by the undersigned on behalf of Director, IWAI, Kolkata from reputed contractors/agencies for supply of necessary workmen for cleaning of water hyacinth/underwater weeds from d/s Jangipur Lock channel as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – I with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to undersigned.

Sealed quotations will be received upto 3:00PM on 01.10.2022 at the office of the Assistant Director, I.W.A.I., Office Building No. 1, FBP Office Complex, PO- Farakka Barrage, PS- Farakka, Murshidabad and will be opened on same day at 4:00PM. in presence of the contractors/agencies or their authorised representatives.

Rates should be quoted for service charges only in %age. The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

#### Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all expenses no extra charges will be payable except wages (as per minimum wage schedule), statutory dues (if any), G.S.T., Insurance and Safety items.
- 2.0 The above supply work should be as per the BOQ & directives of Engineer In Charge or his authorised representative.
- 3.0 Necessary wages and dues for a wage month are to be remitted as per latest minimum wages schedule notified by Central Labour Commissioner to the engaged workmen within 1<sup>st</sup> week of next month in their respective bank accounts. Agency will be required to submit the receipt of such transaction while submitting the claim.
- 4.0 Wages actually paid to the workmen will be reimbursed. The service charges will be calculated on the total wages paid.
- 5.0 The agency should provide necessary safety items like Gum boots, Gloves, Rope etc. during the site activities and same will be reimbursed at par procurement cost of such items.
- 6.0 The engaged labour should be covered under accidental insurance policy. The premium cost will be reimbursed on submission of the original invoice/receipt.
- 7.0 Full payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative within 30 (Thirty) days after satisfactory completion of the work. However Authority will not be responsible for any unavoidable delay.

- 8.0 The firm will be required to submit Tax-Invoice in duplicate at the time of submission of the claim.
- 9.0 The quotation should accompany GST registration, valid Trade License and experience on any similar work carried out at any Government/Quasi-Government/P.S.U. within last 7 years.
- 10.0 Incomplete quotations will be summarily rejected.
- 11.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
