### Terms and Conditions:

- 1.0 Documentary proof of undertaking repairing of DG sets in last 03 years to be submitted by the bidder.
- 2.0 The rates should be quoted inclusive of all taxes, labour, transportation etc. no extra cost will be admissible.
- 3.0 The above work shall be carried out at the address mentioned in Para-1 as per specification mentioned in the B.O.Q. (Annexure - I) and direction of E.I.C. or his representative.
- 4.0 The above work shall be completed within 10 (Ten) days from the date of issue of the work order, which includes to & fro journey to Hemnagar.
- 5.0 90% payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative.
- 6.0 Participating bidder should have valid GST and trade registration and the self certified copies of the same should be submitted along with the quotations.
- 7.0 Incomplete quotations will be summarily rejected.
- 8.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value/awarded work.
