Quotations in sealed envelope are hereby invited by Director, IWAI, Kolkata from reputed contractors/agencies for dismantling the whip antenna and removal of foundation thereof at DGPS station of Swaroopganj, Dist- Nadia, West Bengal as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – A with this N.I.Q. which is to be filled in and submitted along with a forwarding letter addressed to Director,IWAI,Kolkata. The address of sub office Swaroopganj office (place of work) is Village: Fakirtala, P.O: Maheshganj, Nadia, Pin-741315.

Sealed quotations will be received upto 3:00PM on 10.10.2022 at the office of the Director, I.W.A.I., P-78, Garden Reach Road, Kolkata - 700043 and will be opened on same day at 4:00PM in presence of the contractors/agencies or their authorised representatives.

Rates should be quoted inclusive of all charges including Logistic charges. The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all taxes, labour, transportation GST etc. no extra cost will be admissible. GST component shall be shown separately in quotation.
- 2.0 The above work shall be carried out at the address mentioned in Para-1 as per specification mentioned in the B.O.Q. (Annexure I) and direction of E.I.C. or his representative.
- 3.0 The above work shall be completed within 20 (twenty) days from the date of issue of the work order which include 10 (ten) days for mobilization of men & materials at site.
- 4.0 Full payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative. The scrap value of the porta cabins will be deducted from the total cost of the work as per present market rate/Govt. S.O.R The decision of the E.I.C. in this connection will be final and bind on the successful bidder. GST component shall be shown separately in bill.
- 5.0 The removed antennas are to be stored as per directives of E.I.C. or his representative.
- 6.0 Participating bidders should have valid GST and trade registration and the self certified copies should be submitted along with the quotations.
- 7.0 Site should be cleared from all debris and should be restored to existing ground level.
- 8.0 Incomplete quotations will be summarily rejected.
- 9.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
