Quotations in sealed envelope are hereby invited by the undersigned on behalf of Director, IWAI, Kolkata from reputed contractors/agencies for Disconnecting, Dismantling, Removing, Packing & transporting of all the items as mentioned in the BOQ at Annexure-A, as per directives of EIC or his representative under the premises of DGPS station at Swaroopganj, Dist- Nadia, West Bengal as per terms & conditions given below. The details of the work and B.O.Q are enclosed as Annexure – A with this N.I.Q. which is to be filled and submitted along with a forwarding letter addressed to Director, IWAI, Kolkata. Sealed quotations will be received upto 3:00 PM on 10.10.2022 at the office of the Director, I.W.A.I., P-78, Garden Reach Road, Kolkata - 700043 and will be opened on same day at 4:00PM. in presence of the contractors/agencies or their authorised representatives.

Rates should be quoted inclusive of all charges including Logistic charges. The rates shall be quoted legibly both in figure and words and shall be valid up to 90 (Ninety) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0 The rates should be quoted inclusive of all taxes, labour, transportation etc. no extra cost will be admissible. GST component shall be shown separately in quotation.
- 2.0 The above work shall be carried out at the address mentioned in Para-1 as per specification mentioned in the B.O.Q. (Annexure I) and direction of E.I.C. or his representative.
- 3.0 The above work shall be completed within 20 (twenty) days from the date of issue of the work order which include 10 (ten) days for mobilization of men & materials at site.
- 4.0 Full payment will be released only after satisfactory completion of the work and necessary certification by E.I.C. or his Authorised representative.
- 5.0 The removed light poles, fencing wires etc. are to be stored at I.W.A.I. Swaroopganj store as per directives of E.I.C. or his representative.
- 6.0 Participating bidders should have valid GST and trade registration. Self certified copies of the aforesaid documents are to be submitted along with the quotations.
- 7.0 Site should be cleared from all debris and light poles, lights, JB boxes etc. to be stored in Swaroopganj office store. Empty foundation trenches of light posts should be restored to existing ground level. GST component shall be shown separately in bill.
- 8.0 Incomplete quotations will be summarily rejected.
- 9.0 On delay in work L.D. @ 0.5% per week will be deducted from the final payment and maximum of 10% of the work value.
