 The Government of India has received a loan from the World Bank towards the cost of Capacity Augmentation of National Waterway – 1 Project and intends to apply a part of the funds to cover eligible payments under the contract for construction of works as detailed below.

- Bidding will be conducted through National Competitive Bidding procedures agreed with the World Bank. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011_Revised July 2014.
- 3. Bidders from India should, however, be registered with the Government of India or other State Governments / Government of India, or State / Central Government Undertakings. Bidders from India, who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III Evaluation and Qualification Criteria), to qualify for the award of the contract. - 2) The Inland Waterways Authority of India, Ministry of Ports, Shipping and Waterways, Government of India (Implementing Agency) invites online bids for the works detailed below in the table. The bidders may submit bids for any or all of the works indicated therein. Interested bidders may obtain further information and inspect the bidding documents at the address given below during office hours.
- 3) Bidding Documents are available online on CPP Portal https://eprocure.gov.in/eprocure/app from 25.04.2024. A non-refundable fee as indicated in the table below, in the form of Demand Draft (DD) of any Scheduled/Nationalized bank payable at Noida or through RTGS in favour of IWAI Fund Jal Marg Vikas (Payment documents are to be submitted as per the procedure described in paragraph 9 below) shall be submitted along with the bid. Bidders will be required to register on the website. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
- 4) For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. - 5) All Bids must be accompanied by a bid security of the amount specified for the work in the table below, drawn in favour of **IWAI Fund Jal Marg Vikas**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 9.

- 6) Bids comprise two Parts, namely the Technical Part and the Financial Part, and both simultaneously online parts must submitted on CPP https://eprocure.gov.in/eprocure/app (website) on or before 15.00 hours on 25.04.2024 and the 'Technical Part' of the bids will be publicly opened online on the same day at 15.30 hours, in the presence of the bidder's designated representatives who wish to attend. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
- 7) The bidders are required to submit (a) Original payment documents towards the cost of bid document; (b) Original bid security in approved form and (c) Original affidavit regarding correctness of information furnished with bidding document with Vice Chairman & Project Director (JMVP), A-13, Sector-1, NOIDA, Gautam Buddha Nagar 201301, UP before the bid submission deadline, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.
- 8) A pre-bid meeting in hybrid mode will be held on 02.05.2024 at 1500 hours at the office of Inland Waterways Authority of India, NOIDA to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document. Bidders are advised to download the bidding document prior to the pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
