OFFICE ORDER

Consequent upon acceptance of the recommendation of Departmental Promotion Committee and approval of the Board in the 188th Board meeting, the Competent Authority has approved the promotion of Sh. Suhail Rafat, Junior Hydrographic Surveyor to the post of Assistant Hydrographic Surveyor in Level-10 in Pay Matrix of 7th CPC purely on Ad-hoc basis.

- (2) The Ad-hoc promotion shall not confer any right on the officer to continue in the grade of Assistant Hydrographic Surveyor indefinitely or for regular promotion to the grade or to claim seniority in the grade.
- (3) The Ad-hoc promotion shall be for a period of 1 year or filling up of the post on direct recruitment basis, whichever is earlier and subject to undertaking the 03 weeks course at National Institute of Hydrography, Goa within a period of 02 years.
- (4) The Ad-hoc promotion may be terminated at any point of time without giving any reason there of.
- (5) If the officer fails to resume the charge of the post of Assistant Hydrographic Surveyor (on ad-hoc basis) within 30 days of issue of this order, without the prior approval of the Authority for extension in joining time, his ad hoc promotion will be liable to be cancelled.
- (6) The above promotion will take effect from the date of assumption of charge of the post of Assistant Hydrographic Surveyor (on ad-hoc basis).
- (7) Sh. Suhail Rafat, JHS may exercise the option for fixation of pay as per FR (1)(a)(i) within one month from the date of joining as AHS (Ad-hoc).


