**Age Limit:** - Not exceeding 56 years on the closing date of application.

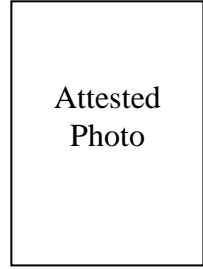
**GENERAL INFORMATION:** -
