Subject: Notification of 'Customs Area' at Tribeni (Bandel) Jetty – Regarding.

1. Attention is invited to the Public Notice No. 15/2019 dated 06.08.2019 issued by this Commissionerate where under Indian Barges/ vessels were allowed to load export goods from Bandel (BTPS) as it was beyond the Riverine Protocol Route.
2. Now vide Notification No. 27/2021-Customs (N.T.) dated 05.03.2021 issued under clause (b) and (c) of sub – Section (1) of Section 7 of the Customs Act, 1962, Tribeni (Bandel) in Hoogly district of West Bengal has been declared as Land Customs Station for trade with Bangladesh through the river route as per the Protocol on Inland Water Transit and Trade between India and Bangladesh connecting Tribeni (Bandel) in India to Bangladesh.
3. Consequent upon the Notification issued by the Board as above, now Indian as well as Bangladeshi vessels / barges can be loaded at Tribeni (Bandel).
4. Now in exercise of the power vested in me under Section 8 (a) and (b) of the Customs Act, 1962, I, Shri Rajesh Jindal, Principal Commissioner of Customs (Preventive), West Bengal, do hereby notify 'Customs Area', as described in Schedule below, at Tribeni (Bandel), for the purpose of loading of fly ash and stone chips for export in barges under Customs supervision and sealing of the same by Customs.
