PROCUREMENT OF FRP BOATS

1. ITB Clause 6.1 and SECTION – III: BID DATA SHEET – EMD – As per OM dated 12.11.2020 of department of Expenditure, on account of slowdown in economy due to the pandemic, there is no provision regarding Bid-security (Earnest money Deposit) and a Bid Security Declaration at Annex-1 is to be submitted.
2. Clause 8.12 of GCC, Liquidated Damages (LD) for Delay shall be read as:
“If the Contractor fails to comply with the SECTION VII: SCOPE OF WORK AND TECHNICAL SPECIFICATIONS, for the whole of the works, then the Contractor shall pay to the Employer the relevant sum stated in the table appended in SCC as LD for such default and not as a penalty (which sum shall be the only monies due from the Contractor for such default). The Employer may, without prejudice to any other method of recovery, withheld / deduct the amount of such damages from any money due or to become due to the Contractor. The amount withheld or deducted against such damages shall not relieve the Contractor from his obligation to complete the Works, or from any other of his obligations and liabilities under the Contract.
